Program Expectations

The following provides a list of expectations regarding your commitment to working with GIFTS on your Life Improvement Plan. By signing this agreement you are committing to participating in weekly A-Team meetings and expectations, monthly staffings, support groups as assigned, and weekly house meetings for a minimum of 6 months.

Good Neighbor Policy

GIFTS Men's Shelter prides itself on the positive reputation we have in our community. This hasn't happened by accident! The foundation of our ministry is built on The Parable of the Good Samaritan (Luke 10:25-37).

What does it mean to a good neighbor?

Being a good neighbor means living with others in a social community called a "neighborhood." People talking in their front yards, children playing on the sidewalk, people mowing lawns, and similar activities are all a part of being neighbors. People are what make a neighborhood a living community rather than just a group of buildings.

What does this mean to you?

You are no longer a guest of the GIFTS, you are a resident living in a home, in a neighborhood. To be a good neighbor:

- Be respectful of neighbors privacy.
- Make sure your house looks clean and organized. This means keeping the yard mowed. Trimming the bushes. Tending the garden. Watering the flowers. Take pride in our property and our neighborhood. Our home will be one that raises property values NOT lower them.
- In the winter, keep the sidewalks and drive shoveled and salted. Help your neighbor with this too if you have the opportunity.
- Lend a hand if you see a neighbor in need.
- Take the trash out and retrieve the empty bins in a timely fashion.
- Keep outside noise to a minimum. Fowl language will not be tolerated.
- Park in designated areas.
- If you see a neighbor outside, smile and wave. If you have an opportunity, introduce yourself and ask them how their day was.

CORRECTIVE ACTION

Similar to your stay at GIFTS Shelter, you stay in the Life Recovery Home will continued to be monitored closely. We take the recovery of all very seriously and therefore we will address any violations promptly.

Ideally, corrective action is handled by conversations and agreements with a resident. If a resident consistently breaks rules, ignores the code of conduct, or is not helping to maintain an intentional, healthy, healing community, you will be asked to leave.

If you do not respond to this coaching, OR if the infraction is serious enough to warrant a more severe consequence, GIFTS uses a strike system. If you have accrued three strikes, you have demonstrated a lack of commitment to your program and by your own actions have chosen to leave the program. Any rule violation can result in a strike, if necessary.

There are certain incidents that can result in immediate removal from the program: Intoxication or use of drugs
Violation of smoking policy
Drug paraphernalia on person or in room
Physical assault
Drugs and/or alcohol intentionally brought on any of the properties
Theft
Vandalism

GRIEVANCE POLICY

If you have a grievance with any staff member, mentor, volunteer, or other resident, GIFTS chooses to follow the Biblical example of conflict resolution found in Matthew 18. The following policy should be followed:

- First, you should go to the person you are having the conflict with and share your concern. NO one is perfect and mistakes can be made It is expected the person will handle the grievance responsibly and with maturity and work towards resolution.
- Second, if the person doesn't respond appropriately, the concern should be brought to the immediate supervisor. The supervisor will investigate the situation and attempt to find resolution.
- Third, if the immediate supervisor doesn't respond appropriately, the concern should be brought to the Men's Ministry Manager who will investigate the situation and attempt to find resolution.
- Fourth, if the Men's Ministry Manager doesn't respond appropriately, the concern should be brought to the Executive Director. If it has been resolved and you simply disagree with the way it was resolved, the Executive Director will not overrule the staff member's decisions unless there is a violation of policy or integrity.. This level of grievance is generally only used in the instance of a wrong-doing, after the others have refused to make things right.
- Finally, if the you still feel the grievance hasn't been resolved by the Executive Director, you may write a written, formal appeal to the board of directors This appeal is not meant as a medium to vent displeasure or dissatisfaction, rather it is a final appeal if there is a serious issue that the Executive Director fails to address appropriately.

ROOM STANDARDS

Rooms must be kept organized and clean

All personal items should have a place and be stored in that place.

Beds should be made soon after getting up for the day.

There should be no personal items laying on your bed.

Rooms should be regularly cleaned and dusted.

No food is allowed in the rooms.

There should not be garbage stored in rooms, other than in a waste can.

Rooms should always be in a condition that is acceptable for giving a tour.

MEDICATIONS

To stay in the Life Recovery House, taking your medications "as prescribed" by your doctor is mandatory. Failure to take medications as prescribed will not be tolerated and will result in termination from the program. In order to ensure your health and safety, GIFTS has zero tolerance for medication misuse.

Medication misuse is defined as: Taking medication that does not belong to you. Sharing your medication with others. Intentionally taking too much of any medication. Taking more or less than prescribed.

Supporting documentation for all prescribed medication must be provided to the Men's Ministry Manager. At that time you will be issued a medication lockbox. Your medication should be kept in this box at all times. Be aware random pill counts will be conducted.

Medications with potential for abuse, such as cough syrup with dextromethorphan are not allowed, unless obtained through prescription and used as prescribed.
